2. Rehearsal rooms and services

The Landesmusikakademie provides rehearsal, seminar or practice rooms for the duration of the occupancy. In principle, there is a claim to the contractually agreed rooms. However, the Landesmusikakademie reserves the right to change the room allocation in justified individual cases.

- **2.1** In principle, the following rooms are provided free of charge for the duration of the event (including instruments and conference equipment, without consumables):
 - a) depending on the group size at least one appropriate conference room
 - b) for bookings of at least 35 nights per calendar day or for bookings of at least 20 rooms the Studio Felix Mendelssohn (DG) and the Studio Hildegard von Bingen (2nd floor) or the Studio Jacques Offenbach (1st floor)
 - c) for bookings of at least 20 nights per calendar day usually the Studio Felix Mendelssohn (DG) or alternatively the Studio Hildegard von Bingen (2nd floor) and the Studio Jacques Offenbach (1st floor)
 - d) for bookings of at least 10 nights per calendar day usually the Studio Hildegard von Bingen (2nd floor)
- **2.2** Additional rooms can be rented per calendar day subject to availability for the following fee. Unless otherwise stated, the billing is done on a half-day basis:
